Payment Information

We will not accept liability for any charges made by banks for bank transfer services. When you place an order, you are making an offer to buy goods or services. We will send you a confirmation to confirm that we have received your order.

Advance payment should be 70% of the total invoice price to confirm the order.

The balance amount should be paid immediately after the delivery of the project and the final invoice is issued.

Returns and cancellations

After 14 days of order confirmation, it is not acceptable to cancel the order under any circumstances and the full advance payment will charge. If you wish to return any goods you must ensure that they are packaged adequately to protect against damage. If you have opened any boxes to examine the product we recommend that you take care with the packaging and try not to damage it as it is specifically designed for the product. If you fail to take reasonable care of the goods before they are returned to us, and these result in damage or deterioration, we will charge accordingly. If you wish to cancel your order within 14 days you must return the goods to us at your own expense.
